GREETINGS: IN THE NAME OF THE STATE OF MAINE YOU ARE HEREBY REQUIRED TO NOTIFY AND WARN THE VOTERS OF THE TOWN OF MEXICO IN SAID COUNTY, QUALIFIED BY LAW TO VOTE IN TOWN AFFAIRS, TO ASSEMBLE AT THE MEXICO MUNICIPAL BUILDING (LOWER HALL) IN SAID TOWN ON **TUESDAY**, THE NINETEENTH DAY OF SEPTEMBER, 2017, AT 6:00 P.M., THEN AND THERE TO ACT ON THE FOLLOWING ARTICLES:

ARTICLE 1: TO CHOOSE A MODERATOR TO PRESIDE AT SAID MEETING

ARTICLE 2: TO SEE IF THE TOWN WILL VOTE TO ADOPT THE ORDINANCE PROHIBITING RETAIL MARIJUANA ESTABLISHMENTS, RETAIL MARIJUANA STORES AND RETAIL MARIJUANA SOCIAL CLUBS

ARTICLE 3: TO SEE IF THE TOWN WILL VOTE TO ALLOCATE \$160,000 FROM THE UNDESIGNATED FUND BALANCE TO REDUCE THE 2017/18 TAX COMMITMENT.
