## **ROAD COMMISSIONER REPORT**

Chairman Richard Philbrick was called by a resident of Backkingdom road with a concern about the back side of the road not being salted. Mr. Philbrick went up to take a look at the road. After talking to the road crew that plows and salts the road it was explained to him that they only salt one side of the hill from Harlow Hill to the top, they do not salt the back side of the hill due to the cost of salt. The selectmen then discussed how they could solve this problem by keeping the roads safe and costs down. It was then decided that the town crew would salt all of Backkingdom road right up the middle from Harlow Hill all the way to too where the road ends at the T.

**\*\*Motedioned by A. Byron Ouellette, second by Reginald Arsenault, Jr., to allow the town crew to salt right up the middle of the road from Harlow Hill all the way to the T in the road on Backkingdom. Voted unanimously to approve.**

Town manager Jack Gaudet says that our salt consumption is good. He also stated that we are still getting calls at the town office from people who are getting wires stuck in their tires. We just keep telling people that it is a D.O.T. road and to either call D.O.T. or call the mill and file a complaint with them.
