## Actions to be taken from the referendum Town Meeting Ordinance:

\*Cliff made a motion to authorize the Tax Collector or Treasurer to accept prepayment of taxes prior to the date of commitment to the Tax Collector, pursuant to Title 36 M.R.S.A Section 506, and issue a receipt for the same. To also authorize the Tax Collector or Treasurer to establish an eight (8) month payment plan known as the "Mexico Tax Club", under such terms and conditions as the Tax Collector or Treasurer deems are in the best interest of the Town, including, but not limited to, the abatement of interest for all members of the Tax Club making regular payments in accordance with any rules and

regulations for said "Mexico Tax Club" established by the Tax Collector or Treasurer. Seconded by Richie, all in favor.

Richie made a motion to establish the dates during the month of October and March each year when taxes for the fiscal period will be due and payable in two equal installments, and to fix the interest rate to be charged on all taxes unpaid after said dates, and to fix the interest rate to be paid by the town on abated taxes pursuant to Title 36 M.R.S.A Section 506 A. The interest rate charged shall not exceed the maximum interest rate authorized each year by the state Treasurer and the interest rate paid shall be fixed at a rate 4% less than the interest rate charged. Interest rates shall be set after review by the budget committee. Cliff seconded, all in favor.

Richie made a motion to authorize the treasurer to deposit State of Maine, Local Road Assistance moneys (LRAP) received each year into the road construction and maintenance reserve account. Seconded by Peter, all in favor.
