^^Cliff made a motion to come out of executive session 1 M.R.S.A 405 (6) (C) at 7:34, seconded by Peter. All in favor


^^Richie made a motion to give property located on Ledgeview Ave back to Chris Chessie upon payment of his taxes. Seconded by Cliff, all in favor.
